THE REST EMERGENCY RECEIVING CENTER (ERC) PROGRAM INCLUDES OUR 24/7 HOTLINE AND AN EMERGENCY SHELTER. THE HOTLINE SERVED 377 INDIVIDUALS WITH 1936 CALLS AND 748 TEXTS OVER THE YEAR. THROUGH THE HOTLINE, WE CAN PROVIDE EMOTIONAL SUPPORT AND SAFETY PLANNING, HELP SURVIVORS CONNECT TO THE SERVICES THEY NEED, AND SCREEN THEM FOR ADMITTANCE TO THE ERC. THE SHELTER CONSISTS OF 7 INDIVIDUAL BEDROOMS FOR ADULT FEMALE-IDENTIFIED INDIVIDUALS WHO HAVE EXPERIENCED THE SEX TRADE. IT IS A LOW BARRIER SHELTER WHERE GUESTS CAN STAY FOR 30 DAYS WITH THE POSSIBILITY OF EXTENDING THEIR STAY TO 60 OR 90 DAYS. IN FY 2021, REST PROVIDED 57 UNIQUE INDIVIDUALS WITH 2,329 BED NIGHTS.

OUR COMMUNITY ADVOCATE TEAM PROVIDES OUTREACH IN THE COMMUNITY, TRAUMA-INFORMED PERSON-CENTERED CASE MANAGEMENT, EMPLOYMENT SERVICES, AND PEER SUPPORT TO REST'S CLIENTS. THIS TEAM PROVIDES CULTURALLY APPROPRIATE AND RESPONSIVE CARE TO CLIENTS OF ALL AGES AND GENDERS BY ASSISTING THEM IN ACCESSING RESOURCES TO AID THEM IN THEIR INDIVIDUALIZED GOALS. IN FY 2021, THE ADVOCATE TEAM ASSISTED REST CLIENTS WITH ATTAINING 717 GOALS.

THE PATHWAYS SERVICES CENTER INCLUDES OUR DROP-IN CENTER, INTEGRATED HEALTH CLINIC, AND THE REST ECONOMIC AND LEADERSHIP EMPOWERMENT ACADEMY. DROP-IN ALLOWS SPACE FOR CLIENTS TO ACCESS BASIC NEEDS, SUCH AS FOOD, CLOTHING, AND A PLACE TO REST. THEY ARE ALSO INVITED TO ENGAGE IN COMMUNITY WORKSHOPS AND APPOINTMENTS THAT FOSTER GROWTH TOWARDS LIFE SKILLS AND SELF-IDENTIFIED GOALS. THE IHC OFFERS APPOINTMENTS WITH LICENSED MENTAL HEALTH THERAPISTS AND ADVANCED REGISTERED NURSE PRACTITIONERS. THE ACADEMY OFFERS JOB READINESS TRAINING, INTERNSHIPS, EMPLOYMENT SERVICES, AND LEADERSHIP DEVELOPMENT WORKSHOPS. IN FY 2021, DROP-IN SERVED 265 UNIQUE INDIVIDUALS, THE IHC 55, AND THE ACADEMY 44.
