

## **Securities Gift Instructions**

To electronically transfer securities from your account to Real Escape from the Sex Trade's account, please provide your brokerage firm with this signed letter of authorization and include the information requested below:

### **STEP 1: INITIATE THE TRANSFER WITH YOUR BROKER/ADVISOR USING THE ATTACHED LETTER OF AUTHORIZATION**

At year-end, please allow several extra days for these types of transactions to be completed.
